Stallholder Terms & Conditions

General

- Items for sale at events other than our Christmas Fair must pre-date 2000 and genuinely considered to be an antique or a collectible.
- You must clearly display their business name and address.
- You will provide your own equipment {i.e. table, gazebo,etc.} and be responsible for complying with any relevant health and safety legislation.
- No consumables are to be sold.
- Arundel Events Ltd. (hereinafter referred to as the *organisers*) will consider all applications, however they reserve the right to refuse any application without giving a reason.

Legal

- You are responsible for complying will all laws and regulations regarding the sale of goods, relevant Trading Standards and Health and Safety legislation.
- Stallholders are required to have £5m Public Liability insurance cover, an appropriate level {normally £10m} of Employers Liability insurance, and Products Liability insurance.
 Evidence of insurance must be provided on request.

On the day

- Events are officially open to the public from 10:00 to 17:00.
- Stallholders have between 07:00 and 09:30 to set up and load stalls, and between 17:00 and 18:00 to close down and remove all their property from the High Street.
- Once unloaded, vehicles must be immediately removed from the High Street and parked legally.
- No vehicular access will be permitted to the High Street between 09:30 and 17:00.
- Stallholders should not close down (unless sold out) during market trading hours.
- Stall areas are to be kept clean and tidy.
- Stallholders are responsible for their own safety and security.
- Stallholders will comply with instructions from the organisers and/or their safety and security representatives.
- Siting of each stall is solely the responsibility of the organisers
- Stallholders are required to provide their own stalls.
